REF: **CRABTREE SWIM & TENNIS (CSTC)
2020 SUPPLEMENTAL POOL RULES/WAIVER - (COVID-19) NC PHASE 2**

1. **LIMITED CAPACITY** – THE EMERGENCY MAXIMUM OCCUPANCY FOR OUR POOL FACILITY HAS BEEN CALCULATED AT **80 PEOPLE**. THE NUMBER OF BATHERS IN THE POOL IS FURTHER LIMITED TO **31 BATHERS** FOR OUR MAIN POOL, AND ANOTHER **3 BATHERS** FOR OUR KID POOL. PLEASE NOTE THAT LIFEGUARDS ALSO COUNT TOWARD THESE TOTALS, AND WE ESTIMATE 1-2 GUARDS MAXIMUM, DURING PHASE 2 POOL OPERATIONS.
2. **SCANNING CHECK-IN/OUT** – ALL MEMBERS WISHING TO USE OUR POOL AND ITS FACILITIES WILL NEED TO CHECK-IN AND CHECK-OUT VIA OUR GOOGLE DOCUMENT AND SHEETS LINK(S) PROVIDED AT OUR POOL ENTRANCE AND BELOW. GIVEN CURRENT MEMBERSHIP LEVELS WE BELIEVE THIS IS THE BEST OPTION FOR OUR MEMBERS, BUT WE WILL ADJUST AS WE RECEIVE ADDITIONAL GUIDANCE AND FEEDBACK.

- **PLEASE NOTE THAT UNDER THE REQUIRED NAME DROPBOX, YOUR FAMILY'S LAST NAME ONLY APPEARS IF YOU HAVE PAID YOUR 2020 CSTC DUES. THEREFORE, IT IS VERY IMPORTANT THAT GO AHEAD AND PAY YOUR DUES OR YOU WILL NOT BE ABLE TO CHECK-IN OR OUT OF THE POOL.**
- THESE LINKS ARE UPDATED AUTOMATICALLY AND CAN BE CHECKED FROM HOME PRIOR TO COMING TO THE POOL FOR A CURRENT NUMBER OF MEMBERS AT THE POOL, WHICH IS WHY IT IS **CRITICAL** THAT ALL MEMBERS **CHECK-IN AND OUT**. REMINDERS TO DO SO ARE AFFIXED TO THE MAIN GATE, AND QR CODES ARE ALSO POSTED IN MAIN BREEZEWAY.
- WE STRONGLY SUGGEST ADDING SHORTCUTS TO THE LINKS ABOVE TO YOUR PHONE'S HOME SCREEN FOR EASE, REPETITION AND TO AVOID ANY BACKUPS AT THE GATE.



3. **SANITATION** - WHILE LIFEGUARDS WILL FOLLOW ENHANCED SANITATION GUIDELINES, IT IS ULTIMATELY THE RESPONSIBILITY OF EACH PERSON TO SANITIZE THEIR OWN FURNITURE. PLEASE SANITIZE THE TABLE AND CHAIRS THAT YOU AND YOUR FAMILY INTEND TO USE UPON ARRIVAL AND DO THE SAME PRIOR TO EXITING THE POOL. (2) SANITATION STATIONS, PROVIDED BY AQUATECH, WILL BE SITUATED IN (2) SEPARATE DESIGNATED AREAS AROUND POOL DECK FOR PUBLIC USE.
4. **MASKS** - WHILE MASKS ARE BEING ENCOURAGED BY THE CDC, THEY ARE **NOT** REQUIRED.
5. **CONCESSIONS** - AT OUR INITIAL OPENING, THE CRAB SHACK WILL **NOT** BE AVAILABLE. WE WILL CONTINUE EXPLORING OPTIONS FOR CONCESSIONS AS THE SUMMER PROGRESSES. HOWEVER, GRILLS WILL BE AVAILABLE FOR USE AT THE SOLE DISCRETION AND RESPONSIBILITY OF USERS, AND THEREFORE YOU WOULD NEED TO BRING YOUR OWN GRILLING UTENSILS. PLEASE NOTE THE USE OF SINKS, FRIDGE, FREEZER, ICE AND CSTC SPORTS EQUIPMENT WILL **NOT** BE ALLOWED. LIFEGUARDS ARE THE ONLY PERSONS ALLOWED IN THE CRAB SHACK AND IT WILL BE LOCKED WHILE THEY ARE ON THE STAND. **OUTSIDE FOOD DELIVERIES ARE ALLOWED, BUT PLEASE MEET DELIVERY PERSON OUTSIDE OF THE MAIN POOL GATE.**
6. **WATER FOUNTAIN:** ONLY THE BOTTLE FILLER COMPONENT OF OUR WATER FOUNTAIN WILL BE AVAILABLE FOR USE AT THE SOLE DISCRETION AND RESPONSIBILITY OF USERS. **IT IS HIGHLY RECOMMENDED THAT YOU BRING YOUR OWN COOLERS WITH ICE AND BEVERAGES.**
7. **GUESTS** - AT OUR INITIAL OPENING, **NO** GUESTS WILL BE ALLOWED. THIS MAY CHANGE THROUGHOUT THE PHASES AS WE UNDERSTAND MORE ABOUT OUR POOL CAPACITY, USAGE PATTERN AND AS GUIDELINES CHANGE.
8. **RESTROOMS** – ALL SHOWERS IN EACH OF OUR BATHROOMS WILL BE CLOSED, HOWEVER OUR OUTDOOR SHOWER WILL REMAIN AVAILABLE FOR USE, BUT PLEASE ONLY USE, AS NECESSARY. WE WILL BE LEAVING RESTROOM DOORS OPEN WHEN **NOT** IN USE, AND SINGLE-FAMILY USERS SHALL CLOSE DOOR UPON ENTRY AND RE-OPEN DOOR UPON EXIT, SO THAT EVERYONE KNOWS IF RESTROOM IS OCCUPIED. PLEASE WIPE DOWN THE SINK AREA TO HELP KEEP OUR RESTROOMS CLEAN IN BETWEEN OFFICIAL SANITIZATIONS.
9. **UNACCOMPANIED CHILDREN** - UNACCOMPANIED CHILDREN, 16 YEARS OF AGE AND OLDER, WILL BE ALLOWED WITH THE UNDERSTANDING THAT ALL RULES ARE ADHERED TO AND IS SUBJECT TO CHANGE IF THIS BECOMES AN ISSUE. ONCE SWIM TEAM PRACTICE RESUMES, THEY WILL HAVE SEPARATE OPERATING PROCEDURES, WHICH MAY DIFFER FROM ABOVE.



10. **BREAKS** – WE WILL STILL HAVE OUR STANDARD 10-MINUTE BREAK AT THE END OF EACH HOUR. WE ARE ALSO INITIALLY GOING TO HAVE A 30-MINUTE, **EXTENDED BREAK FROM 2:50 - 3:20P EACH DAY** FOR ADDITIONAL SANITATION OF HIGH-TOUCH AREAS BY OUR LIFEGUARD(S). MEMBERS WILL **NOT** HAVE TO LEAVE THE POOL DECK, BUT ALL CHILDREN WILL HAVE TO REMAIN OUT OF THE POOL DURING THESE CLEANING SESSIONS. ADULT SWIM WILL BE ALLOWED DURING THESE TIMES, BUT PLEASE GIVE OUR LIFEGUARDS SPACE TO PERFORM THEIR SANITATION DUTIES. THESE BREAKS ARE SUBJECT TO CHANGE, AND WE WILL ADJUST AS NECESSARY TO MEET THE NEEDS OF OUR FACILITY. **THERE WILL STILL BE A STANDARD 3:50P BREAK FOLLOWING EXTENDED BREAK.**
11. **TOYS** – THERE WILL BE **NO** TOYS PROVIDED AT THE POOL. HOWEVER, YOU CAN BRING TOYS FROM HOME FOR PERSONAL USE. THE POOL-SIDE BASKETBALL GOAL IS STILL AVAILABLE FOR USE, BUT IT IS 'BRING YOUR OWN BALL' TO PLAY. **NO FLOATS ALLOWED! PLEASE REMEMBER TO TAKE ALL TOYS HOME WITH YOU AT THE END OF EACH DAY.**
12. **LOST & FOUND** – ALL PERSONAL ITEMS LEFT AT THE POOL AT THE END OF THE DAY WILL BE PLACED IN A BIN OUTSIDE OF THE CRAB SHACK UNTIL **NOON** THE FOLLOWING DAY. ALL UNCLAIMED ITEMS WILL BE DISCARDED AT THE AFOREMENTIONED TIME.
13. **SWIM TEAM** - SWIM TEAM/PRACTICE WILL LOOK VERY DIFFERENT THIS YEAR, BUT THERE IS A STRONG INTEREST IN HAVING SOME FORM OF A SWIM TEAM. IF INTERESTED, PLEASE MAKE SURE YOU SIGN UP VIA TSA SWIM TEAM MANGER WEBSITE. WE ARE HOPING TO START SWIM PRACTICE AS SOON AS POSSIBLE. GUIDELINES, SCHEDULE, AND FEES WILL BE SENT OUT SHORTLY. FOR THOSE MEMBERS WHO HAVE ALREADY PAID THEIR 2020 SWIM TEAM DUES, REIMBURSEMENTS CAN BE MADE ONCE NEW FEES ARE ESTABLISHED.
14. **OTHER POOL ACTIVITIES** - WE ALL WANT TO RESUME OUR CSTC VOLLEYBALL, BASKETBALL, ADULT LAP SWIM, WATER AEROBICS, AND SOCIALS. THERE IS NO DOUBT THE INTEREST IN THESE ACTIVITIES WILL BE GREATER THAN EVER, BUT WE ARE **NOT** THERE JUST YET. STAY TUNED! WE ARE REQUESTING THAT THE REPRESENTATIVES OF EACH OF THESE ACTIVITIES PREPARE GUIDELINES AND PROTOCOLS THAT WILL BE REVIEWED BY OUR BOARD MEMBERS AND WILL ONLY BE IMPLEMENTED UPON BOARD APPROVAL.
15. **INFRACTIONS** - MEMBERS WHO FAIL TO ADHERE TO THE RULES WILL BE ASKED TO LEAVE THE FACILITY. IF THIS IS AN UNACCOMPANIED CHILD, HE OR SHE WILL LOSE THE ABILITY TO COME BACK WITHOUT SUPERVISION. WE ARE MOVING INTO UNCHARTED TERRITORY, AS ALWAYS PLEASE DO WHAT IS BEST FOR YOU AND YOUR FAMILY AS EVERYONE'S CIRCUMSTANCES ARE DIFFERENT. WHILE OUR LIFEGUARDS WILL BE HELPING US WITH ADDITIONAL SAFETY AND SANITATION MEASURES, IT IS ULTIMATELY THE RESPONSIBILITY OF ALL MEMBERS/OWNERS TO WORK TOGETHER THROUGH THESE PHASES.



PLEASE SHOW GRACE AND PATIENCE TO ALL, ESPECIALLY CHILDREN AS SOCIAL DISTANCING IS NOT ALWAYS WELL UNDERSTOOD. PLEASE HAVE PATIENCE WITH US AS WELL AS WE WORK THROUGH THIS PLAN. WE WILL MAKE ADJUSTMENTS AS WE RECEIVE GUIDANCE FROM OUR COUNTY/STATE AND AS WE HEAR FEEDBACK FROM OUR MEMBERSHIP.
